

PRIVACY POLICY

The purpose of this document is to inform the natural person (hereinafter the "Data Subject") about the processing of their personal data (hereinafter "Personal Data") collected by the data controller, UNCLE S.r.l., with registered office at Via Roma No. 18, 22020 Torno (CO), VAT/Tax ID 04057190136, email address info@uncleboats.com (hereinafter the "Controller"), through the website www.uncleboats.com (hereinafter the "Application"). Any changes and updates shall be binding as soon as they are published on the Application. If the Data Subject does not accept the amendments applied to the Privacy Policy, they are required to cease using this Application and may request the Controller to delete their Personal Data.

1. Categories of Personal Data processed

The Controller processes the following types of Personal Data voluntarily provided by the Data Subject: Contact details: name, surname, address, email, phone, images, authentication credentials, any additional information provided by the Data Subject, etc. Tax and payment data: tax code, VAT number, credit card details, bank account information, etc. Failure to provide the Personal Data for which there is a legal or contractual obligation, or if they are a necessary requirement for entering into a contract with the Controller, shall result in the Controller's inability to establish or continue the relationship with the Data Subject. The Data Subject who communicates the Personal Data of third parties is directly and exclusively responsible for their origin, collection, processing, communication, or dissemination.

2. Cookies and Similar Technologies

The Application uses cookies, web beacons, unique identifiers, and comparable technologies to gather the Personal Data of the Data Subject pertaining to visited pages, followed links, and other actions performed when using the Application. 3. Legal Basis and Purpose of the Processing

The processing of Personal Data is necessary: a. for the implementation of the contract with the Data Subject, and more specifically: a. compliance with any obligations arising from the pre-contractual or contractual relationship with the Data Subject b. to meet all legal obligations, specifically: compliance with any obligations established by laws and regulations in force and particularly in tax and fiscal matters. The Personal Data of the Data Subject may also be used by the Controller for their legal defense in court before judicial authorities having jurisdiction.

4. Methods of Personal Data Processing and Recipients.

Personal Data processing is performed using both paper and electronic means, with organizational methods and logical structures directly associated with the specified purposes, while adopting appropriate security measures. The Personal Data is processed exclusively by: individuals authorized by the Data Controller and bound by confidentiality or having an appropriate legal obligation of confidentiality; entities operating independently as separate data controllers or designated by the Data Controller as data processors to carry out all the processing activities necessary to achieve the purposes described in this privacy policy (for example, business partners, consultants, IT companies, service providers, and hosting providers); entities or authorities to whom it is mandatory to disclose Personal Data due to legal obligations or orders issued by the authorities. The aforementioned entities are required to use appropriate safeguards to protect Personal Data and may only access the data necessary to perform their assigned tasks. The Personal Data will not be indiscriminately disclosed in any way.

5. Location

The Personal Data will not be subject to any transfer outside the European Economic Area (EEA).

6. Duration of Personal Data Retention

The Personal Data shall be retained for the time necessary to fulfill the purposes for which they were collected, in particular: For purposes related to the implementation of the contract between the Controller and the Data Subject, they shall be retained for the term of the contractual relationship and, after its termination, for the ordinary mandatory period of 10 years. In the case of legal disputes, they shall be retained for the entire duration of the dispute, until the expiry of the statute of limitations for legal actions. For purposes related to the legitimate interest of

the Controller, they shall be retained until the completion of said interest. For compliance with a legal obligation, by order of an authority, or for legal defense, they shall be retained in accordance with the timing provided for by these obligations, regulations, and, in any case, until the statute of limitations is in force. For purposes based on the Data Subject's consent, they shall be retained until the consent is revoked. At the end of the retention period, all Personal Data will be deleted or stored in a form that does not allow the identification of the Data Subject.

7. Rights of the Data Subject

The Data Subjects can exercise specific rights concerning their Personal Data processed by the Controller.

In particular, the Data Subject has the right to be informed about the processing of their Personal Data, withdraw consent at any time, restrict the processing of their Personal Data, object to the processing of their Personal Data, access their Personal Data, verify and request the correction of their Personal Data, obtain the limitation of the processing of their Personal Data, obtain the erasure of their Personal Data, transfer their Personal Data to another Controller, file a complaint with the data protection supervisory authority regarding their Personal Data, and/or take legal action. Requests will be promptly acknowledged by the Controller and processed as quickly as possible, in any case, within 30 days.
